

## PRIVACY POLICY

8 May 2018

We would like to inform you that Flagowa Kraina Sp. z o.o. with its registered headquarters in Skrzyszów (44-348 Skrzyszów, ul. Powstańców Śląskich 234; ('Flagowa Kraina' or 'the Company')) processes data provided by Users and business partners in connection with the use of services and conclusion of contracts. This information may include information that constitutes personal data within the meaning of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC ('the Regulation' or 'the GDPR').

Out of concern for the security of the data entrusted to us, we are constantly improving our safeguards, as well as developing internal procedures and recommendations that are designed to protect personal data. We check the correctness and quality of our safeguards on an ongoing basis in accordance with the GDPR and other relevant legal acts.

In accordance with the applicable Regulation, in order to ensure an adequate level of personal data protection, the data subject should be provide with all information regarding the processing of personal data set out in Article 13 and/or 14 of the GDPR (depending on whether the information was obtained directly from the subject, or from other sources).

Therefore, we would like to inform you that:

- 1) The administrator of the information obtained by the Company is Flagowa Kraina Spółka z ograniczoną odpowiedzialnością with its registered office in Skrzyszów (44-348 Skrzyszów, ul. Powstańców Śląskich 234), entered into the Register of Entrepreneurs of the National Court Register kept by the District Court in Gliwice, 10th Commercial Division of the National Court Register, under National Court Register number 0000075570, NIP (Tax ID): 6472267386, REGON (National Business Registry number): 277714555.
- 2) Contact with the Administrator: in writing by post to the address ul. Powstańców Śląskich 234, 44-348 Skrzyszów, or via e-mail to [rodo@flagi.pl](mailto:rodo@flagi.pl).
- 3) Personal data are processed pursuant to legal provisions and/or for the purpose of performing a contract concluded between the parties (Article 6(1) of the GDPR).
- 4) The Company acquires personal data in the following manner:
  - a) using information voluntarily entered in forms,
  - b) using information contained in contracts,
  - c) by collecting 'cookies' via the [www.flagi.pl](http://www.flagi.pl) website (see: the 'Cookies' policy).
- 5) Personal data are always collected and processed for one purpose, which arises under a specific form or contract.

- 6) In addition, personal data are also processed for statistical purposes.
- 7) Flagowa Kraina does not process special categories of personal data within the meaning of Article 9 of the Regulation.
- 8) Personal data are processed for the period necessary to implement the legitimate interests of the Company.
- 9) In connection with the processing of personal data, the data subject has the right to:
  - a) request that the Administrator provides access to their personal data,
  - b) request that the Administrator rectifies their personal data,
  - c) request that the Administrator erases their personal data,
  - d) requests that the Administrator restricts the processing of their personal data,
  - e) object to the processing of the personal data,
  - f) move the personal data,
  - g) lodge a complaint to the supervisory body.
- 10) The rights specified above in item 8 can be exercised via:

- 11) The Administrator shall make every effort to provide all possible available means to physically, technically and organisationally protect the data against accidental or deliberate destruction, loss, modification, disclosure or unauthorised use, in accordance with applicable regulations.
- 12) At the Company, the personal data are processed in paper and electronic form in accordance with the purposes of processing.
- 13) The personal data whose Administrator is Flagowa Kraina will not be sold or disclosed to unauthorised third parties.
- 14) We reserve the right to change the privacy policy. The Company will inform about any changes in a clear and comprehensible manner.
